New Member	 New member price is for 1st time members of the Kapuskasing Golf Club 	 A junior member in 2019 who returns after more than 5 years is eligible for the new member pricing in 2024. A member is not eligible for the new member pricing more than once. For example, a person under the age of 30 who paid the new member pricing in 2023 is not eligible for the Young Professional 1 (YP1) pricing in 2024.
Returning Member	 Applies to previous KGC members that want to return as a member. A member is eligible as a returning member only once within a 10-year period. (2015-2024) 	 A Returning Member in 2022, does not renew in 2023 is not eligible in 2024. A 2022 member who was not a member in 2023 is eligible as a returning member in 2024, providing he/she was not previously a Returning Member.
Student	 Post secondary students. Must be currently enrolled and/or enrolled in the fall. Proof required. Does not apply to part-time students, continuing education courses, etc. 	 A student is eligible for the Young Professional (YP1) after graduating from the Student Membership category.
Young Professional 1	• Applies to members 30yrs and under at the time of purchase.	The membership has to be paid in full before turning 31.
Young Professional 2	Eligible for YP2, if paid as YP1 in previous year	Example 1; Age 27
Young Professional 3	Eligible for YP3, if paid as YP2 in previous year	2021 = YP1 Age 27 2022 = YP2 Age 28 2023 = YP3 Age 29 2024 = YP3 Age 30
